His research in the field of philosophy of education thus focuses on the issue of quality education in the face of denialism and interrelated tendency of a subject to avoid knowledge. Grušovnik published several scientific papers in various journal, edited and co-edited several monographs, and lectured at different institutions in Asia, Australia, North America and Europe. In 2015 he chaired program committee of the scientific conference “Educational Paradigms” that took place at the University of Primorska.

Mitja Sardoč (PhD) is a researcher at the Educational Research Institute in Ljubljana (Slovenia) where he is member of the ‘Social Contract in the 21<sup>st</sup> Century’ research programme. He is author of several scholarly articles and editor of a number of journal special issues on citizenship education, multiculturalism, toleration, equal opportunities and patriotism. He is Managing Editor of *Theory and Research in Education* (<http://tre.sagepub.com/>) and member of the editorial board of *Educational Philosophy and Theory* and the *Open Review of Educational Research*. Andraž Teršek, pravnik in doktor (ustavnega) prava, je doktoriral na Pravni fakulteti v Ljubljani, kjer je bil v letih 1998–2008 zaposlen kot asistent. V tem času se je uveljavil kot pravni teoretik in filozof, predvsem pa kot ustavni pravnik. Za njegovo ukvarjanje s pravom so značilni upiranje pravniškim dogmam in klišejem, konstruktivna kritičnost do pravne realnosti, vztrajanje na trajnem upravičevanju prava z razumnostjo, logiko in moralo, opazovanje temeljnih pravnih vprašanj in problemov z nekoliko drugačnih zornih kotov, vnašanje novosti in novih študijskih pristopov v svetu pravne znanosti. Spisal je številna strokovna in znanstvena besedila s področja ustavnega prava, demokracije, človekovih pravic in drugih sorodnih tem. Bil je pomočnik urednika revije *Dignitas*. Je avtor dveh knjižnih del o svobodi izražanja. Je pobudnik, soustanovitelj in sourednik prve slovenske revije za ustavno pravo *REVUS*. Zaposlen je na Univerzi na Primorskem, kjer na Pedagoški fakulteti tudi predava.
