





BRUTO INVESTICIJE V OSNOVNA SREDSTVA, SLOVENIJA 2002
GROSS FIXED CAPITAL FORMATION, SLOVENIA 2002

- V letu 2002 so podjetja, družbe in organizacije ustvarila za 933,1 milijarde SIT investicij v nova in rabljena osnovna sredstva, leto prej pa 850,4 milijarde SIT.
- Nominalni porast je glede na leto 2001 znašal 9,8 %.
- V celotni strukturi investicij so največji delež obsegale investicije v nove stroje, opremo in prometna sredstva, in sicer 48,1 %.
- Največ vseh investicij v nova osnovna sredstva, to je 67,2 %, so ustvarila področja D, L, G, I in E.
- Med občinami je po deležu vseh bruto investicij v nova osnovna sredstva na prvem mestu Ljubljana z 31,3 %.
- Skoraj polovico vseh investicij v Sloveniji v letu 2002 so ustvarile občine Ljubljana, Maribor, Koper, Celje in Kranj.
- In 2002, enterprises, companies and organisations paid SIT 933.1 billion for gross fixed capital formation (new and existing assets), while in 2001 SIT 850.4 million was paid.
- The nominal increase in comparison with 2001 was 9.8%.
- The greatest share of total gross fixed capital formation was paid for new machinery, transport and other equipment, i.e. 48.1%.
- The greatest share of gross fixed capital formation (67.2%) was created by sections D, L, G, I and E.
- Among municipalities, the greatest share of total gross capital formation was created in Ljubljana (31.3%).
- Almost a half of total gross capital formation in Slovenia was created in municipalities Ljubljana, Maribor, Koper, Celje and Kranj.

METODOLOŠKA POJASNILA

Namen statističnega raziskovanja

Na podlagi statističnega raziskovanja o investicijah v osnovna sredstva zbiramo podatke o dejanskih bruto investicijah v osnovna sredstva in njihovih virih pri neposrednih investitorjih, to je družbah, podjetjih in organizacijah. S pomočjo zbranih podatkov še iz drugih statističnih raziskovanj (predvsem iz gradbeništva, zunanjega trgovine in kmetijstva) pa ocenjujemo bruto investicije v osnovna sredstva ne samo za pravne osebe (finančni, nefinančni in državni sektor), ampak tudi za sektor gospodinjstev (predvsem takrat, ko se pojavljajo kot investitorji lastne gradnje oz. nakupov stanovanj in kot samostojni podjetniki). Ocena bruto investicij (bruto investicije v osnovna sredstva, spremembe zaloga in vrednostni predmeti) je ena od postavk (poleg končne potrošnje in saldo menjave s tujino) za izračun bruto domačega proizvoda po izdatkovni metodi.

Enote opazovanja

Enote statističnega opazovanja so družbe, podjetja in organizacije, ki so registrirani za opravljanje dejavnosti na ozemlju Republike Slovenije in zaposlujejo najmanj 10 oseb.

Vir

Vir podatkov o bruto investicijah je Letno poročilo o investicijah v osnovna sredstva (obrazec - INV-1).

METHODOLOGICAL EXPLANATIONS

Purpose of the statistical survey

With the statistical survey on gross fixed capital formation we collect data on actual gross fixed capital formation and payment for it from direct investors, i.e. companies, enterprises and organisations. With the help of already collected data from other statistical surveys (especially from the field of construction, external trade and agriculture), we estimate gross capital formation not only for legal persons (financial, non-financial and government sector) but also for the sector of households (especially when households appear as investors of own construction or purchase of dwellings and as individual private entrepreneurs). The estimate of gross capital formation (gross fixed capital formation, changes in stocks and valuables) is one of the items (beside final consumption and external trade balance) for the calculation of the gross domestic product according to the expenditure approach.

Observation units

Observation units are companies, enterprises and organisations registered for performing their activities in the Republic of Slovenia and employing at least 10 persons.

Source

The source of data on gross capital formation is the Annual Report on Gross Fixed Capital Formation (INV-1 form).

Zajetje

Statistični urad RS zbira podatke o investicijah v osnovna sredstva neposredno pri investitorjih že od leta 1966. Do leta 1992 smo z vprašalnikom INV-01 zbirali podatke o investicijah samo pri podjetjih in organizacijah v družbeni, mešani in zadružni lasti. Z letom 1992 smo uvedli še dodatno raziskovanje Letno poročilo o investicijah v osnovna sredstva zasebnih podjetij (vprašalnik INV-03). Zavoljo sprememb v sistemu lastništva podjetij pa smo z letom 1995 obe nadomestili z enotnim raziskovanjem Letno poročilo o investicijah v osnovna sredstva (INV-01). S tem vprašalnikom smo zbirali podatke o investicijah pri vseh enotah, ki so pravne osebe (podjetja, družbe in organizacije), ne glede na število zaposlenih, razen pri organizacijski obliki d. o. o., kjer so zajete le pravne osebe s tremi ali več zaposlenimi. Stopnja odzivnosti pravnih oseb se je v obdobju med leti 1995 in 2001 dosegala od 82 % do 89 %. Podatke o investicijah smo zbrali pri vseh večjih in pomembnih pravnih osebah z 10 ali več zaposlenimi in tako zajeli ok. 90 % vseh investicij.

Pri zbiranju **podatkov o investicijah za leto 2002** pa smo vključili vse tiste poročevalske enote, ki so **imele več kot 10 zaposlenih**. Pri sektorju država pa smo vključili vse poročevalske enote. Njihova odzivnost je bila **85 - odstotna, za neodgovore pa smo izvedli preračun na celotno populacijo** z razmernostno cenilko, in sicer tako, da smo uporabili **amortizacijo osnovnih sredstev iz zaključnih računov oz. število zaposlenih**.

Način zbiranja podatkov

Podatke zbiramo z vprašalnikom INV-1, ki ga morajo družbe, podjetja in organizacije izpolnjevati s podatki za preteklo leto na podlagi Zakona o državni statistiki (Uradni list, št. 45/95 in 9/01).

Prikaz podatkov

Z letom 2002 smo tabelo Izplačila za investicije v nova in rabljema osnovna sredstva nadomestili s tabelo Viri financiranja, ki se nanašajo na poročevalsko leto. Tako je vrednost virov financiranja enaka vrednosti bruto investicij. Zbirali pa smo podatke tudi o plačanih in neplačanih virih financiranja, ki jih objavljamo v tabeli 2a. Vendar pa ta tabela ni primerljiva s tabelami iz prejšnjih let, saj so te vsebovale tudi podatke poravnanih obveznostih iz prejšnjih let.

V tabeli 1 prikazujemo investicije po posameznih skupinah osnovnih sredstev po metodologiji SNA93/ESA95 in sicer nakupe novih in rabljenih ter njihove prodaje. Poročevalske enote, ki nam poročajo o investicijah, lahko svoja obstoječa osnovna sredstva prodajajo ne samo drugi pravni osebi, ampak tudi gospodinjstvom kot trajno dobrino, npr. avtomobil, ki s tem izgubi funkcijo osnovnega sredstva. Tako so v določenih postavkah prodaje večje od nakupov rabljenih osnovnih sredstev, zato prikaz investicij na ta način po posameznih dejavnostih ni smiseln.

Podatki v tabelah 2, 2a, 3, 3a, 4, in 5 so urejeni po dveh načelih:

- po organizacijskem načelu: podatki so razvrščeni po pretežni dejavnosti investitorja (ta je določena z vpisom v enotni register, ki ga vodi Statistični urad Republike Slovenije) in teritorialno - po sedežu investitorja;
- po načelu čistih dejavnosti: podatki so urejeni po dejavnosti enot v sestavi v okviru organizacij, ki so jim investicije namenjene, teritorialno pa po lokaciji objekta.

Definicije

Vrednost investicij v osnovna sredstva obsega:

- nakupe (fizično ustvarjenih - plačanih in neplačanih) lastnih osnovnih sredstev v tekočem oz. pročevalskem letu;
- posodobitve, rekonstrukcije in prenove na že obstoječih osnovnih sredstvih; (štejejo se kot investicije v nova osnovna sredstva) ne glede na to, ali so bili v poročevalskem letu plačani ali ne;
- lastno izgradnjo in pridobitev (brez plačila) osnovnih sredstev ter
- nabavno vrednost osnovnih sredstev v finančnem najemu (lizing).

Coverage

The Statistical Office has been collecting data on fixed capital formation from investors since 1966. Until 1992 we were collecting data with the INV-01 questionnaire only from enterprises and organisations in social, mixed and co-operative ownership. In 1992 we introduced an additional survey Annual Report on Gross Fixed Capital Formation of Private Enterprises (INV-03 questionnaire). Because of changes in the system of enterprise ownership, in 1995 we substituted both surveys with the Annual Report on Gross Fixed Capital Formation (INV-01). With this questionnaire we collected data on capital formation from all legal persons (companies, enterprises and organisations), irrespective of ownership, except for limited liability companies where only legal persons with three or more employees are covered. Between 1995 and 2001 the response rate of legal persons was 82-89%. Data were collected from all major legal persons with 10 or more persons in paid employment and thus covered about 90% of all capital formation.

In collecting **data on capital formation for 2002** we included all reporting units that had **over 10 persons in paid employment**. In the government sector we covered all reporting units. Their response rate was **85%**. For **non-response**, we performed **recalculation to the total population with the ratio estimator, using depreciation of fixed assets from final accounts or the number of persons employed**.

Method of data collection

Data are collected with the INV-1 questionnaire, which has to be answered by companies, enterprises and organisations with data for the previous year on the basis of the National Statistics Act (OJ RS, No. 45/95 and 9/01).

Data presentation

In 2002 the table Payments for gross fixed capital formation (new and existing assets) was replaced by the table Sources of financing referring to the reporting year. The value of sources of financing is thus the same as the value of gross fixed capital formation. We have also collected data on paid and unpaid sources of financing, which are published in table 2a. However, this table is not comparable with tables from previous years because they covered data on settled liabilities from previous years.

Table 1 shows capital formation by individual groups of fixed assets according to SNA93/ESA95 methodology, i.e. purchase and sale of new and existing assets. Units reporting on capital formation can sell their fixed assets not only to other legal persons but also to households as durable goods, e.g. cars, which thus lose the function of a fixed asset. Thus in individual items sale exceeds purchase of existing fixed assets, so it is not reasonable to present capital formation in this way by individual activities.

Data in Tables 2, 2a, 3, 3a, 4 and 5 are shown according to two principles:

- organisational principle: data are classified by the predominant activity of the investor, which is defined with registration into the register kept by the Statistical Office of the Republic of Slovenia, and territorially by the location of the investor,
- kind of activity principle: data are classified by activities of constituent units of organisations for which capital formation is in fact intended and territorially by the location of the facility.

Definitions

Value of gross capital formation is:

- purchase of new own fixed assets (paid and unpaid) in the current or reporting year;
- modernisation, reconstruction and renovation of existing fixed assets; (counted as fixed capital formation for new assets), whether paid in the reporting year or not;
- own formation (without payment) of fixed assets,
- purchase value of fixed assets in financial leasing.

Osnovna sredstva (nova in rabljena) se vrednotijo po nabavni vrednosti, ki se sestojijo iz nakupne cene, povečane za morebitne davke (npr. DDV), stroške prevzema in druge neposredne stroške (npr. stroški transporta, montaže ipd.).

Osnovna sredstva

To so **proizvedena sredstva**, ki se uporabljajo v proizvodnem procesu več kot eno leto, in sicer ponavljajoče oz. nepretrgoma. Osnovna sredstva obsegajo: opredmetena in neopredmetena osnovna sredstva.

V skladu z ESA-95/SNA-93 in slovenskimi računskimi standardi smo osnovna sredstva razdelili v dve veliki skupini:

- **opredmetena osnovna sredstva** (gradbeni objekti in izboljšava zemljišč, stroji, oprema in prometna sredstva ter večletni nasadi in osnovna čreda) in
- **neopredmetena osnovna sredstva** (študije, projekti in raziskovalna dela; programska oprema; zabava in izvirniki oz. originali na področju filma, glasbe ipd.).

Nakupov zemljišč ne štejemo več kot investicijo v osnovna sredstva. Upoštevamo le stroške transakcij z njimi.

V vrednosti gradbenih del upoštevamo tudi vrednost opreme, ki je vgrajena v gradbene objekte, v vrednost opreme pa so zajeti tudi stroški montaže, transporta in zavarovanja.

Viri financiranja investicij

To so vsi viri oz. izdatki, ki so potrebni za financiranje investicij za nova in rabljana osnovna sredstva in so: iz lastnih sredstev (tudi realizacija v lastni režiji), iz združenih sredstev, iz finančnih sredstev (krediti in finančni najem), iz sredstev posebnih namenskih skladov ter pridobitev osnovnih sredstev brezplačno.

Plačane investicije so tista opravljena dela na obstoječih osnovnih sredstvih in nabave novih in rabljenih osnovnih sredstev, ki so bila plačana v poročevalskem letu. Za plačana štejejo tudi osnovna sredstva, ki so jih poročevalske enote pridobile brezplačno.

Opravljena, toda ne plačane investicije so vse neporavnane obveznosti do izvajalcev in dobaviteljev v poročevalskem letu, kot npr. porabljeni komercialni krediti in neplačan kredit oz. lizing, sklenjeni v poročevalskem letu; avansi, ki so bili plačani v prejšnjih letih, vendar obračunanvi v poročevalskem letu.

Vrednost ustvarjenih investicij v poročevalskem letu obsegajo plačane in neplačane investicije v nova in rabljena osnovna sredstva, ki so v uporabi kot tudi tisti del nedokončanih investicij, ki je bil ustvarjen v poročevalskem letu.

Investicije v nove zmogljivosti so vlaganja za ustanavljanje novih samostojnih podjetij, organizacij in obratov ter graditev prometnih poti, ki jih prej ni bilo ali pa so imele drugačen namen kot na novo zgrajene.

Investicije za razširitev, rekonstrukcijo in posodobitev so vlaganja v obstoječe zmogljivosti zaradi povečanega obsega proizvodnje ali storitev ali zaradi spremembe tehnologije in tehnike proizvodnje; zajemajo tudi preureditev že obstoječih objektov, opreme in naprav in tudi graditev ali nabavo novih osnovnih sredstev v sklopu že obstoječe organizacijsko samostojne delovne enote.

Investicije za vzdrževanje obstoječih zmogljivosti na enaki ravni so vlaganja zaradi zamenjave, intenzifikacije in racionalizacije proizvodnje, ne da bi širili razpoložljive zmogljivosti ali bistveno spremenjali sedanje tehnologijo ali tehniko proizvodnje.

Opomba: Zaradi zaokroževanja na mio SIT se vsota vrednosti v vrsticah oz. stolpcih ne ujema povsem s skupno vrednostjo.

Fixed assets (new and existing) are valued at purchase value, which is composed of purchase price plus eventual taxes (e.g. VAT), costs of delivery and other direct costs (e.g. transport, assembly, etc.).

Faxed assets

are **produced assets** that are used continuously in the production process for more than a year. Fixed assets are divided into tangible and intangible fixed assets.

In accordance with ESA-95/SNA-93 and Slovenian accounting standards, we divided fixed assets into two large groups:

- **tangible fixed assets** (construction work, land improvement, machinery, transport and other equipment, orchard development and breeding stock) and
- **intangible fixed assets** (studies, projects and research work; software and originals in the field of film, music, etc.).

Purchase of land is no longer part of fixed capital formation. Only transaction costs are taken into account.

Construction work also includes the value of equipment built in the buildings. The value of equipment includes costs of assembly, transport and insurance.

Sources of financing capital formation

These are all sources or expenditure necessary for financing capital formation for new and existing fixed assets. They are divided into own financial assets, joint assets, financial credits, assets of funds and acquisition without compensation.

Paid capital formation is work performed on existing fixed assets and purchase of new and existing fixed assets that were paid in the reporting year. Paid fixed assets are also those that the reporting units acquired free of charge.

Created but unpaid capital formation is all unsettled liabilities towards contractors or suppliers in the reporting year, e.g. used commercial credits and outstanding credits (leasing) raised in the reporting year, and advance payment in previous years calculated in the reporting year.

The value of capital formation created in the reporting year covers paid and unpaid capital formation for new and existing fixed assets used as well as that part of unfinished capital formation that was created in the reporting year.

Gross fixed capital formation in new capacities is investment in creating new enterprises, organisations and units, construction of roads, etc., which previously did not exist or had other purpose than the newly built.

Gross fixed capital formation for enlargement, reconstruction and renovation is investment in existing capacities because of increased volume of production or services, or because of the change of technology. It also covers reorganisation of existing buildings and equipment, and construction or purchase of new fixed assets within the scope of an existing organisationally independent unit.

Gross fixed capital formation for maintenance of existing capacities at the same level is investment due to replacement, intensification and rationalisation of production, but without expanding the existing capacities or fundamentally changing the present technology.

Note: In some tables the total in the rows and columns does not correspond to the total value due to rounding to million SIT.

KOMENTAR:

V letu 2002 so podjetja, družbe in organizacije ustvarila za 933,1 milijarde SIT investicij v nova in rabljena osnovna sredstva, leto prej pa 850,4 milijarde SIT. Nominalni porast glede na leto 2001 znaša 9,8 %. To pomeni realno povečanje, saj je bila povprečna stopnja inflacije v letu 2002 7,5-odstotna, rast cen industrijskih proizvodov pri proizvajalcih pa je v istem obdobju bila v povprečju 5,1-odstotna.

Viri investicije v osnovna sredstva so bila največja iz lastnih sredstev in združenih sredstev (67,4 %), sledili so jim viri iz finančnih sredstev (18,8 %) in iz namenskih skladov (12,6 %). Pridobitev osnovnih sredstev brez denarnih nadomestil pa je znašala 1,2 % vseh sredstev.

V letu 2002 je bilo vseh plačanih investicij 83,5 %, preostala so bile opravljene, niso pa bile plačane.

V celotni strukturi investicij v nova osnovna sredstva v letu 2002 so največji delež obsegale investicije v stroje, opremo in prometna sredstva, 48,1 %, investicije v gradbeni del so zavzemale 46,7 %, neopredmetenim sredstvom, večletnim nasadom in osnovni čredi pa je namenjeno bilo namenjenih 5,2 % investicij.

Največji delež investicij v nova osnovna sredstva je ustvarila industrija (področja C, D, E in F), in sicer 35,1 %, sledili so sektor države (področja L, M, N in O) s 27,1 %, področje G (trgovina; popravlja motornih vozil) s 13,6 % in področje I (promet, skladiščenje, zveze) z 10,5 % vseh investicij.

Med občinami je bila po deležu vseh ustvarjenih investicij na prvem mestu občina Ljubljana (31,3 %); sledile so ji občine Maribor (6,2 %), Koper (4,3 %), Celje (4,1 %) in Kranj (3,5 %).

Omenjenih pet občin je v letu 2002 ustvarilo skoraj polovico (49,4 %) vseh investicij v Sloveniji.

COMMENT:

In 2002, enterprises, companies and organisations paid SIT 933.1 billion for gross fixed capital formation (new and existing assets), while in 2001 SIT 850.4 million was paid. The nominal increase in comparison with 2001 was 9.8%, which means that there was real increase since the annual inflation rate in 2002 was 7.5% and producer prices rose by 5.1%.

Sources of financing fixed capital formation were mostly own financial assets and joint assets (67.4%), followed by financial credits (18.8%) and assets of funds (12.6%). Obtaining fixed assets without monetary compensation represented 1.2% of gross fixed capital formation.

In 2002, paid capital formation represented 83.5% of the total capital formation.

In the total structure of gross fixed capital formation (new assets) in 2002, the greatest share (48.1%) was that of capital formation for machinery, transport and other equipment, followed by capital formation for construction work with 46.7%, and intangible fixed assets, orchard development and breeding stock with 5.2%.

The greatest share of gross fixed capital formation (new assets) was created by industry (sections C, D, E and F) with 35.1%, followed by the government sector (sections L, M, N and O) with 27.1%, section G (trade; repair of motor vehicles) with 13.6% and section I (transport, storage and communication) with 10.5% of total capital formation.

Among municipalities, the greatest share of gross fixed capital formation was created in Ljubljana (31.3%), followed by Maribor (6.2%), Koper (4.3%), Celje (4.1%) and Kranj (3.5%).

In 2002 the mentioned five municipalities created almost a half (49.4%) of total gross fixed capital formation in Slovenia.
