## **Povzetek**



#### **2.1 Priprava in izdelava koncepta**

V tem delu bom predstavil pripravo in izdelavo slikovnega koncepta. S pomočjo modelirnega orodja Microsoft Visio Professional 2007 bom vizualno prikazal tako posamične entitete informacijskega problema kot tudi proces reševanja informacijskega problema.



**2.2 Slika 1: Koncept reševanja informacijskega problema**

Slika 1 prikazuje koncept reševanja informacijskega problema (v nadaljevanju IP) po stopnjah od ena do šest:

1. predstavitev IP
2. tema IP, specialne enote in prijetje storilcev
3. naslov IP
4. določitev predmetnih oznak (policija, policijska pooblastila, specialne enote, prijetje, storilci, kazniva dejanja, ZPOL, prekrški, kazenski postopki)
5. uporaba orodij
6. predstavitev (namiznega) mini-portala

Slika 1 vključuje tudi pomembne prvine kot so različne omejitve (npr. za jezik, čas in vrsta virov). V nadaljevanju tega dela bom prikazal vsebinski koncept ali miselni vzorec kot osnova za izdelavo kasnejše namizne aplikacije (namiznega) mini-portala.


### 3 Izdelava vsebinskega omrežja



Slika 3 prikazuje interaktivna spletna programska orodja, aplikacije idr. za sodelovalno reševanje problemov t.j. npr. interaktivno možgansko viharjenje in izdelavo miselnih vzorcev (gl. sliko 3 - levo zgoraj, WiseMapping), reševanje problemov s pomočjo nizanja idej in problemov (gl. sliko 3 - desno zgoraj, Solvr), aplikacijski sistem za izmenjavo gradiv, diskusije in modelov (gl. sliko 3 - levo spodaj, Box.com) in nenazadnje še raziskovalno omrežje ResearchGate (gl. sliko 3 - desno spodaj). Slike znotraj preglednice so klikalne! Sodelovanje določenega posameznika je pogojeno z registracijo in nato prijavo v sistem!



3.3 Slika 4: Namizna aplikacija ali namizni mini-portal na temo specialne enote in prijetje storilcev

Slika 4 prikazuje namizno aplikacijo ali namizni informacijski mini-portal v obliki klikalne sheme na osnovi teme s področja policije, nadzora in mobinga (gl. točko 1 TEMA IP). Sleherna slikovna entiteta vsebuje eno spletno povezavo (razen točka 7 Zbirke - vsebuje dve spletni povezavi t.j. Google učenjak in Science direct).

**Pomoč:** S številkami označene entitete od 2 do 4.4 vsebujejo neposreden dostop do slovenske vzajemne zbirke podatkov COBISS/COIBIB, ki so že v obliki pripravljenih poizvedb. Spodnje entitete po številkami od 3 do 5.4 vsebujejo povezave oziroma že pripravljene poizvedbe za lokalno zbirko podatkov COBISS/MNZRS. Poizvedbe so pripravljene tako za slovenske, angleške, nemške kot tudi za srbske, hrvaške in bosanske publikacije. Različno obarvani in s spletnimi povezavami opremljenimi valji na klikalnem diagramu predstavljajo različne poizvedbe v različnih jezikih na iskalniku Google in Google učenjaku npr. na levi strani se nahajajo poizvedbe z Googla, medtem ko so na desni strani poizvedbe z Googla učenjaka. Točka 6 do 6.4 vsebuje koristne spletne povezave do e-revij s področja policije in sorodnih področij (npr. Policing) Točka 7 vsebuje spletne povezave do velikih zbirk podatkov kot so npr. Springer-link, Emerald, Elsevier, JSTOR in Wiley. Klikalni diagram vsebuje (gl. spodaj) še druge spletne povezave do Googlovin knjig, DKIP (digitalna knjižnica informacijskih problemov) in Web of science (WoS)

Shranjene podatke v obliki .RIS datoteke sem v nadaljevanju uvozil v programsko orodje za upravljanje z bibliografskimi zapisi, ki se imenuje JabRef.
