Sok iz črvov

Znanstveniki, ki so preverjali havajske pravljice o starem načinu zdravljenja raka, pišejo, da črvi tropskega morja zares vsebujejo nekaj sestavin, ki pri miškah preprečujejo razvoj zločestih bul. Seveda ne pripočajo, da bi te tropske črve vpisali na seznam zdravil proti raku, sodijo pa, da se učinek na miši in stare zgodbe o zdravljenosti teh morskih živali presenetljivo ujemajo in da je vse skupaj vredno nadaljnjih raziskav.

Frank Tahbrah, Midori Kašivagi in Ted Norton s havajske univerze so v reviji "Science", glasilu ameriškega združenja za pospeševanje znanosti, objavili poročilo o svojem delu v okviru širših raziskav stare polinezijske medicine. Na črva jih je opozorila stara Havajka, ki jim je povedala, da se stanje ljudi, obolelih za rakom, vidno izboljša, če nekaj tednov redno pijejo juho "kaunaoa", v kateri so kuhane tipalke teh črvov.

"Podobna poročila o zdravljenem učinku sokov v tropskih črvih prihajajo tudi iz kitajske četrti na Havajih. Tam sokove sesajo s tankimi bambusnimi cevkami iz živih morskih črvov," pišejo raziskovalci, ki so med poskusi okužili laboratorijske miši s povzročitelji raka, nato pa so jih zdravili s sokovi iz tropskih črvov. Ugotovitev: v 60 do 100 odstotkih so te sestavine preprečevale rast tumorjev. Zdaj pripravljajo nadaljnje raziskave.
