CONTRIBUTION TO BE PAID FOR 1951 BY NON-RURAL CHEMISTS' SHOPS

WHEREAS it is deemed advisable to fix the rate of contribution to be paid for 1951 by non-rural chemists' shops, in terms of art. 115 of the Consolidated Text of sanitary laws, in that part of the Free Territory of Trieste administered by the British-United States Forces,

NOW, THEREFORE, I, JOHN L. WHITELAW, Brigadier General U. S. Army, Director General, Civil Affairs,

ORDER:

ARTICLE I

The contribution to be paid by chemists' shops, excluding rural ones, is hereby fixed for 1951 at the same rate as that established for 1950 in Article II, first paragraph, of Order No. 28 dated 6 February 1951.

ARTICLE II

This Order shall become effective on the date of its publication in the Official Gazette.
