

BRUTO INVESTICIJE V OSNOVNA SREDSTVA, SLOVENIJA, 2008 GROSS INVESTMENT, SLOVENIA, 2008

- ▶ V letu 2008 so podjetja, družbe in organizacije ustvarili za 6.731,4 milijona EUR investicij v nova in rabljena osnovna sredstva.
- ▶ V celotni strukturi investicij so največji delež obsegale investicije v nove in rabljene gradbene objekte, in sicer skoraj 53 %.
- ▶ Največji delež vrednosti vseh investicij v nova in rabljena osnovna sredstva (več kot 78 %), so ustvarile dejavnosti, ki so v SKD 2008 uvrščene v področja C, H, O, G, J, D in K.
- ▶ Občina Ljubljana je med vsemi občinami ustvarila največji delež vrednosti vseh bruto investicij v nova osnovna sredstva (več kot 30 %).
- ▶ Več kot polovico vrednosti vseh investicij v Sloveniji v letu 2008 so ustvarili v občinah Ljubljana, Maribor, Koper, Novo mesto, Celje in Kranj.
- ▶ Vrednost vlaganj na prebivalca je bila največja v osrednjeslovenski regiji (4.409 EUR), sledili sta ji obalno-kraška regija (4.236 EUR) in jugovzhodna Slovenija (3.151 EUR).
- ▶ In 2008, enterprises, companies and organisations paid EUR 6,731.4 million for gross investment (new and existing assets).
- ▶ The largest share of total gross investment was paid for new and existing buildings and structures, i.e. 53%.
- ▶ The largest share of gross investment - new and existing assets (more than 78%) was created by sections C, H, O, G, J, D and K of the Standard Classification of Activities (SKD 2008).
- ▶ As regards municipalities, the largest share of gross investment in new assets was created in Ljubljana (more than 30%).
- ▶ In 2008 more than a half of total gross investment in Slovenia was created in municipalities Ljubljana, Maribor, Koper, Novo mesto, Celje and Kranj.
- ▶ The largest per capita investment by statistical regions was observed in the Osrednjeslovenska region (EUR 4,409), followed by Obalno-Kraška (EUR 4,236) and Jugovzhodna Slovenija (EUR 3,151).

Podjetja, družbe in organizacije z najmanj 20 zaposlenimi so v letu 2008 ustvarili za 6.731,4 milijona EUR investicij v nova in rabljena osnovna sredstva, leto pred tem pa za 6.214,3 milijona EUR. Nominalna rast bruto investicije glede na leto 2007 je bila tako več kot 8-odstotna. To pomeni realno povečanje, saj je bila povprečna stopnja inflacije v letu 2008 5,7-odstotna.

Viri za financiranje bruto investicij

Podjetja, družbe in organizacije so sredstva za svoje investicije v letu 2008 črpali v glavnem iz lastnih virov in iz združenih sredstev, in sicer so iz tega vira pridobili 49,1 % sredstev; iz finančnih kreditov in lizinga so pridobili 33,1 % sredstev; viri iz namenskih skladov (predvsem iz proračuna države in občin) ter osnovna sredstva, pridobljena brez denarnih nadomestil (brezplačno), so predstavljali 17,8 % vseh sredstev za investicije v nova in rabljena osnovna sredstva. V primerjavi z letom 2007 se struktura virov financiranja ni bistveno spremenila; lastni viri so ostali na enaki ravni; viri iz finančnih kreditov in lizinga so se povečali, financiranje iz namenskih skladov pa se je zmanjšalo (slika 2).


In 2008, enterprises, companies and organisations employing 20 or more employees created EUR 6,731.4 million gross investment (new and existing assets); in 2007 EUR 6,214.3 million was created. The nominal increase compared to 2007 was more than 8.0%, which means that there was a real increase since the annual inflation rate in 2008 was 5.7%.

Sources of financing of gross investment

In 2008 the enterprises financed their gross investment mostly by own financial assets and joint assets (49.1%), followed by financial credits and leasing (33.1%). Obtaining assets of funds - mostly from the state and municipalities budgets - and fixed assets without monetary compensation represented 17.8% of gross investment in new and existing fixed assets. Compared to 2007 the structure of financing did not change significantly; own financial assets remained on the same level and the financial assets increased. The financing from own funds decreased as well (Figure 2).


BRUTO INVESTICIJE PO DEJAVNOSTI

Prikaz strukture bruto investicij v nova in rabljena osnovna sredstva v letu 2008 kaže, da je bila vrednost vlaganj največja v industriji (področja dejavnosti B, C, D in E po SKD 2008), in sicer je dosegla več kot 30-odstotni delež vrednosti vseh investicij v nova in rabljena osnovna sredstva (slika 3).

GROSS INVESTMENT BY ACTIVITY

The largest investment was created by industry (sections B, C, D and E) with more than 30% of total investment in 2008, which is shown in the structure of gross investment. (Figure 3).

Figure 3: Structure of gross investment in new and existing assets by activity of investor (SKD 2008), Slovenia, 2008





V letu 2008 so največji delež vrednosti vseh investicij v nova in rabljena osnovna sredstva v primerjavi z letom 2007 ustvarile predelovalne dejavnosti (področje C), in sicer 21,4 % vrednosti, leto prej pa 22,5 %. Sledile so jim naslednje dejavnosti: promet in skladiščenja (področje H) z 18,0 %, dejavnost javne uprave in obrambe; dejavnost socialne varnosti (področje O) s 13,1 % in trgovina; popravila motornih vozil (področje G) z 9,1 %. V letu 2007 je dejavnost promet in skladiščenje (področje H) ustvarila 16,7 % vrednosti vseh investicij, dejavnost javne uprave in obrambe; dejavnost socialne varnosti (področje O) 16,9 % in trgovina; popravila motornih vozil (področje G) 8,7 % vrednosti vseh investicij (slika 4).


Kot smo že ugotovili, je bilo nominalno povečanje vrednosti bruto investicij v letu 2008 v primerjavi s predhodnim letom več kot 8-odstotno. Primerjava podatkov po področjih dejavnosti med letoma 2008 in 2007 kaže, da se je vrednost investicijskih vlaganj najbolj povečala v zdravstvu (področje dejavnosti Q), in sicer za 124 %. Vrednost investicijskih vlaganj v druge dejavnosti (področje S), je bila večja skoraj za 81 %, v strokovne, znanstvene in tehnične dejavnosti (področje M) za 67, v dejavnosti gostinstvo (področje I) skoraj za 62 % in v dejavnost ruderstvo (področje B) več kot za 40. V vseh omenjenih področjih dejavnosti so se v letu 2008 v primerjavi z letom 2007 povečale investicijske naložbe v gradbene objekte (slika 5).

Both in 2008 and in 2007 the largest share of gross investment in new and existing assets was created by manufacturing (section C); in 2008 21.4% and in 2007 22.5%. In 2008 section C was followed by transport, storage and communication (section H) with 18.0%, public administration (section O) with 13.1% and wholesale, trade and repair of motor vehicles (section G) with 9.1%. In 2007 section C was followed by transport, storage and communication (section H) with 16.7%, public administration (section O) with 16.9% and wholesale, trade, repair of motor vehicles (section G) with 8.7% (Figure 4).

As already stated, compared to 2007 the nominal increase in gross investment in 2008 was more than 8%. The data comparison between 2007 and 2008 by sections of activity shows that the largest increase in investment was recorded in human health and social work activities (section Q) with 124%. An increase of nearly 81% was recorded in other service activities (section S). In professional, scientific and technical activities (section M) an increase of 67% was recorded. The increase in investment was shown in 2008 compared to 2007 also in accommodation and food service activities (section I) with almost 62%. An increase of more than 40% was also observed in mining and quarrying (section B). In 2008 compared to 2007 in all mentioned sections of activity an increase of investing in construction work was observed. (Figure 5).

Figure 5: Gross investment in new and existing fixed assets by activity of investor (SKD 2008), Slovenia, 2007 and 2008





BRUTO INVESTICIJE GLEDE NA NAMEN INVESTIRANJA

Bruto investicije v nova osnovna sredstva v letu 2008 so znašale 6.401,4 milijona EUR, leto prej pa 5.944,6 milijona EUR. Zanimiv je prikaz strukture vrednosti bruto investicij glede na namen investiranja v letu 2008 kjer v gradbeništvo (področje F) razporedimo gradbena inženirska dela, predvsem ceste V letu 2008 se je največ vlagalo v predelovalne dejavnosti (področje C), in sicer 21,9 % vrednosti vseh investicij. Sledile so dejavnosti gradbeništvo (področje F) s 15,9 %, trgovina; popravila motornih vozil (področje G) z 9,2 %, dejavnost javne uprave in obrambe; socialne varnosti (področje O) z 8,7 % in promet in skladiščenje, (področje H) z 7,6 %. Omenjena področja dejavnosti (C, F, G, O in H), v katera se je investiralo, so obsegala več kot 63-odstotni delež vrednosti vseh investicij v nova osnovna sredstva v letu 2008 (slika 6).

Bruto investicije v osnovna sredstva


V sliki 7 prikazujemo bruto investicije v nova in rabljena osnovna sredstva po skupinah. V letu 2008 so se v primerjavi s predhodnim letom najbolj povečala vlaganja v naslednja osnovna sredstva: v stanovanske stavbe (za 78,9 %), v neopredmetena osnovna sredstva (za 21,0 %) in v nestanovanske stavbe (za 17,7 %).

Gross investments in fixed assets

Figure 7 presents gross investments in new and existing assets by groups. In 2008 the largest investment increase over the previous year was observed in the following fixed assets: dwellings (by 78.9%), intangible fixed assets (by 21.0%) and non-residential buildings (by 17.7%).

Figure 7: Gross investment in new and existing assets by types of fixed assets, Slovenia, 2007 and 2008





Deleži bruto investicij v stroje, opremo, transportna sredstva in gojena naravna sredstva so bili največji v predelovalnih dejavnostih (področje C), saj so tam za te namene namenili 68,8 % vrednosti vseh investicijskih sredstev v letu 2008. Sledile so dejavnosti rudarstvo (področje B) s 66,2 %, druge raznovrstne dejavnosti (področje N) s 65,3 % in gradbeništvo (področje F) z 59,8 %. Gradili pa so največ v dejavnosti poslovanje z nepremičninami (področje L), saj so za gradbene objekte in izboljšavo zemljišč namenili 83,2 % vrednosti vseh bruto investicij v letu 2008, sledili so dejavnost javne uprave in obrambe; dejavnost socialne varnosti (področje O) s 75,2 %, gostinstvo (področje I) s 74,5 %, oskrba z vodo, ravnanje z odpadki in odpadki; saniranje okolja (področje E) z 71,6 % in izobraževanje (področje P) z 71,1 % (slika 8).

The share of gross investment in machinery, equipment, transport equipment and cultivated assets was the largest in manufacturing (section C) as for that purpose 68.8% of total investment was intended in 2008. This was followed by mining and quarrying(section B) with 66.2%, administrative and support service (section N) with 65.3% and construction (section F) with 59.8%. Most construction took place in real estate activities (section L), where in 2008 83.2% of total investment from that section was intended for construction work and land improvement, followed by public administration (section O) with 75.2%, accommodation and food service activities (section I) with 74.5%, water supply services, sewerage, waste management and remediation activities (section E) with 71.6% and education (section P) with 71.1% (Figure 8).

BRUTO INVESTICIJE PO TERRITORIALNI RAZDELITVI

Podatke o bruto investicijah v nova osnovna sredstva prikazujemo tudi po občinah in statističnih regijah.

Bruto investicije po občinah

V občinah je bilo v letu 2008 investiranih v nova osnovna sredstva 6.401,4 milijona EUR, leto prej pa 5.944,6 milijona EUR. Med občinami je bila v letu 2008 po deležu vseh ustvarjenih investicij v nova osnovna sredstva, na prvem mestu občina Ljubljana (30,5 %); sledile so ji občine Maribor (6,5 %), Koper (4,3 %), Novo mesto (3,5 %), Celje (3,1 %), in Kranj (2,0 %). V omenjenih šestih občinah je bila v letu 2008 ustvarjena skoraj polovica (49,9 %) vrednosti vseh investicijskih sredstev v Sloveniji (slika 9).

GROSS INVESTMENT BY CLASSIFICATION OF TERRITORY


The data on gross investment by classification of territory are shown by municipalities and statistical regions.

Gross investment by municipalities

In municipalities EUR 6,401.4 million was invested in 2008 in new assets, while in 2007 EUR 5,944.6 million was invested. Among the municipalities the largest share of gross investment was created in Ljubljana (30.5%), followed by Maribor (6.5%), Koper (4.3%), Novo mesto (3.5%), Celje (3.1%) and Kranj (2.0%). Nearly a half (49.9%) of total investment was created in the mentioned six municipalities (Figure 9).

Figure 9: Structure of gross investment in new assets by municipalities where investment was created, Slovenia, 2007 and 2008





Prikaz bruto investicij v nova osnovna sredstva kaže, da se je v občinah v letih 2007 in 2008 investiralo največ sredstev predvsem v gradbene objekte, sledili so stroji; oprema, prometna sredstva in gojena naravna sredstva, in sicer v povprečju v obeh letih okoli 96 % (slika 10).

In 2008 and 2007 municipalities mostly invested in construction work, followed by machinery; equipment, transport and cultivated assets with on average around 96% of total gross investment in new assets (Figure 10).


Bruto investicije po statističnih regijah

V statističnih regijah je bilo v letu 2008 investiranih v nova osnovna sredstva 6.401,4 milijona EUR, leto prej pa 5.944,6 milijona EUR.

Struktura bruto investicij v nova osnovna sredstva po statističnih regijah, v letih 2007 in 2008, kaže, da je največji delež vrednosti vseh investicij v obeh letih prispevala osrednjeslovenska regija (v letu 2008 35,6 %, v letu 2007 pa 38,2 %), za njo pa podavska regija (14,1 % v letu 2008 in 13,6 % v letu 2007) in za to savinjska regija (10,5 % v letu 2008 in 11,0 % v letu 2007) (slika 11).

Zanimiv je prikaz bruto investicij v nova osnovna sredstva na prebivalca po regijah. V obeh letih se je največ vlagalo naslednjih treh regijah: v osrednjeslovenski regiji (v letu 2008 4.409 EUR, v letu 2007 4.482 EUR na prebivalca), v obalno-kraški regiji (v letu 2008 4.236 EUR, v letu 2007 3.056 EUR na prebivalca) in v jugovzhodni Sloveniji (v letu 2008 3.151 EUR, v letu 2007 2.695 EUR na prebivalca). 
Gross investment by statistical regions

In statistical regions EUR 6,401.4 million was invested in 2008 in new assets, while in 2007 EUR 5,944.6 million was invested.

In the Osrednjeslovenska statistical region the largest share of gross investment was created in 2008 (35.6%) and in 2007 (38.2%) – this was revealed by the review of the structure of gross investment in new assets by statistical regions. This region was followed by Podavska with 14.1% of total investment in 2008 and 13.5% in 2007 and Savinjska with 10.5% of total investment in 2008 and 11.0% in 2007 (Figure 11).

METODOLOŠKA POJASNILA

Namen statističnega raziskovanja

Na podlagi statističnega raziskovanja o investicijah v osnovna sredstva zbiramo podatke o dejanskih bruto investicijah v osnovna sredstva in njihovih virih pri neposrednih investitorjih, to je družbah, podjetjih in organizacijah. Ocena bruto investicij (bruto investicije v osnovna sredstva, spremembe zalog in vrednostni predmeti) je ena od postavk (poleg končne potrošnje in salda menjave s tujino) za izračun bruto domačega proizvoda po izdatkovni metodi, podatki pa se uporabljajo tudi za spremljanje investicijske dejavnosti v statistiki o poslovanju podjetij (struktura statistika podjetij).

Enote opazovanja

Enote statističnega opazovanja so družbe, podjetja in organizacije, ki so registrirani za opravljanje dejavnosti na ozemlju Republike Slovenije.

Vir

Vir podatkov o bruto investicijah je Letno statistično raziskovanje o investicijah v osnovna sredstva (vprašalnik INV-1).

Zajetje

V raziskovanje o investicijah za leti 2007 in 2008 smo zajeli vse tiste poročevalske enote, ki so imele vsaj 20 zaposlenih (tj. 20 in več). Njihova odzivnost je bila v letu 2007 91-odstotna, v letu 2008 pa 92-odstotna, za manjkajoče odgovore (neodgovore) pa smo izvedli preračun na celotno populacijo z razmernostno cenilko, in sicer tako, da smo uporabili bazo podatkov o davku na dodano vrednost Davčne uprave Republike Slovenije oz. število zaposlenih.

Način zbiranja podatkov

Podatke zbiramo z vprašalnikom INV-1 pri družbah, podjetjih in organizacijah, ki so nam dolžni sporočati zahtevane podatke na podlagi Zakona o državni statistiki (Uradni list RS, št. 45/95 in 9/01), in sicer vneseno v vprašalnik podatke za preteklo leto.

Prikaz podatkov

Podatke o investicijah prikazujemo v tabeli po posameznih skupinah osnovnih sredstev po metodologiji Evropski sistem računov, 1995 (ESR 1995), in sicer podatke o nakupih novih in rabljenih osnovnih sredstev ter o njihovih prodajah. Poročevalske enote, ki nam sporočajo podatke o investicijah, lahko svoja obstoječa osnovna sredstva (npr. avtomobil) prodajo drugi pravni osebi ali tudi gospodinjstvom kot trajno dobrino (ta s tem izgubi funkcijo osnovnega sredstva). Tako so vrednosti prodaj v določenih postavkah večje od vrednosti nakupov rabljenih osnovnih sredstev, zato prikaz investicij na ta način po posameznih dejavnostih ni smiseln.

Podatki so urejeni po dveh načelih:

- po organizacijskem načelu: podatki so razvrščeni po pretežni dejavnosti investitorja (ta je določena z vpisom v Statistični poslovni register, ki ga vodi Statistični urad Republike Slovenije) in teritorialno (po sedežu investitorja);
- po načelu čistih dejavnosti: podatki so urejeni po dejavnostih enot v sestavi v okviru organizacij, ki so jim investicije namenjene, teritorialno pa po lokaciji objekta.

Definicije

Vrednost investicij v osnovna sredstva obsega:

- nakupe osnovnih sredstev v tekočem oz. poročevalskem letu;
- posodobitve, rekonstrukcije in prenove že obstoječih osnovnih

METHODOLOGICAL EXPLANATIONS

Purpose of the statistical survey

With the statistical survey on gross investments we collect data on actual gross investments and payment for them from direct investors, i.e. companies, enterprises and organisations. The estimate of gross capital formation (gross investments, changes in stocks and valuables) is one of the items (beside final consumption and external trade balance) for the calculation of the gross domestic product according to the expenditure approach. The data are also used for monitoring of investments in structural business statistics.

Observation units

Observation units are companies, enterprises and organisations registered for performing their activities in the Republic of Slovenia.

Source

The source of data on gross capital formation is the Annual Statistical Survey on Gross Investments (INV-1 questionnaire).

Coverage

Data on gross investment for 2007 and 2008 were collected from all reporting units with 20 or more employees. Their response rate was 91% in 2007 and 92% in 2008. In case of non-response, we performed recalculation to the total population with the ratio estimator, using the value added tax database of the Tax Authority or the number of employees.

Method of data collection

Data on gross investment are collected with the INV-1 questionnaire, which has to be completed by companies, enterprises and organisations with data for the previous year on the basis of the National Statistics Act (OJ RS, No. 45/95 and 9/01).

Data presentation

Tables show gross investment by individual groups of fixed assets according to the European System of Accounts 1995 (ESA95) methodology, i.e. purchase and sale of new and existing assets. Units reporting on capital formation can sell their fixed assets not only to other legal persons but also to households as durable goods, e.g. cars, which thus lose the function of a fixed asset. Thus in individual items sale exceeds purchase of existing fixed assets, so it is not reasonable to present capital formation in this way by individual activities.

Data in tables are shown according to two principles:

- organisational principle: data are classified by the predominant activity of the investor, which is defined with registration into the Statistical Business Register kept by the Statistical Office of the Republic of Slovenia, and territorially by the location of the investor;
- kind of activity principle: data are classified by activities of constituent units of organisations for which capital formation is in fact intended and territorially by the location of the facility.

Definitions

Value of gross investment is:

- purchase of fixed assets in the current or reporting year;
- modernisation, reconstruction and renovation of existing fixed assets;

sredstev;

- lastno izgradnjo in pridobitev (brez plačila) osnovnih sredstev;
- nabavno vrednost osnovnih sredstev v finančnem najemu (lizing);
- naložbeno nepremičnino, če je razvidno, da bo ta prinašala gospodarske koristi v obliki najemnin oz. povečanje vrednosti, in če je njeno nabavno vrednost mogoče izmeriti.

Osnovna sredstva (nova in rabljena) se vrednotijo po nabavni vrednosti; ta sestoji iz nakupne cene, povečane za morebitne davke (npr. DDV), stroške prevzema in druge neposredne stroške (npr. stroški transporta, montaže ipd.).

Osnovna sredstva

To so **proizvedena sredstva**, ki se uporabljajo v proizvodnem postopku več kot eno leto, in sicer ponavljajoče oz. nepretrgoma.

Osnovna sredstva se v skladu z ESR 1995 in slovenskimi računskimi standardi delijo v dve veliki skupini:

- **opredmetena osnovna sredstva** (gradbeni objekti – stanovanjske in nistanovanjske stavbe ter gradbeni inženirski objekti – in izboljšava zemljišč; stroji, oprema in prometna sredstva ter gojena naravna sredstva oz. večletni nasadi in osnovna čreda) in
- **neopredmetena osnovna sredstva** (študije, projekti in raziskovalna dela; programska oprema; zabava in izvirniki oz. originali na področju filma, glasbe ipd.).

Nakupov zemljišč od leta 1996 ne štejemo več za investicijo v osnovna sredstva.

V vrednosti *gradbenih del* upoštevamo tudi vrednost opreme, ki je vgrajena v gradbene objekte, v vrednost *opreme* pa so zajeti tudi stroški montaže, transporta in zavarovanja.

Viri za financiranje investicij

To so vsi viri oz. izdatki, ki so potrebni za financiranje investicij v nova in rabljena osnovna sredstva in se lahko pridobijo: iz lastnih sredstev (tudi realizacija v lastni režiji), iz združenih sredstev, iz finančnih sredstev (krediti in finančni najem), iz sredstev posebnih namenskih skladov iz Slovenije in Evropske unije ter pridobitev osnovnih sredstev brez nadomestil oz. brezplačno.

Bruto investicije v nove zmogljivosti so vlaganja za ustavljanje novih samostojnih podjetij, organizacij in obratov ter graditev prometnih poti, ki jih prej ni bilo ali pa so imela drugačen namen kot na novo zgrajene.

Bruto investicije za razširitev, rekonstrukcijo in posodobitev so vlaganja v obstoječe zmogljivosti zaradi povečanega obsega proizvodnje ali storitev ali zaradi sprememb tehnologije in tehnike proizvodnje; zajemajo tudi preureditev že obstoječih objektov, opreme in naprav ter tudi graditev ali nabavo novih osnovnih sredstev v sklopu že obstoječe organizacijsko samostojne delovne enote.

Bruto investicije za vzdrževanje obstoječih zmogljivosti na enaki ravni so vlaganja zaradi zamenjave, intenzifikacije in racionalizacije proizvodnje, ne da bi širili razpoložljive zmogljivosti ali bistveno spremenjali sedanjо tehnologijo ali tehniko proizvodnje.

- own formation of fixed assets and gratis fixed assets;
- purchase value of fixed assets in financial leasing;
- real estate as an investment asset if it contributes to economic benefits in the sum of rents or it expresses the enlargement of the value; and if it is possible to measure the purchase value.

Fixed assets (new and existing) are valued at purchase value, which is composed of purchase price plus eventual taxes (e.g. VAT), costs of delivery and other direct costs (e.g. transport, assembly, etc.).

Fixed assets

are **produced assets** that are used continuously in the production process for more than a year.

In accordance with ESA-95 and Slovenian accounting standards, fixed assets are divided into two large groups – i.e. tangible and intangible fixed assets:

- **tangible fixed assets** include construction work, land improvement, machinery, transport and other equipment, orchard development and breeding stock, whereas
- **intangible fixed assets** include studies, projects and research work; software and entertainment and originals in the field of literature, film, music, etc.

Since 1996 purchase of land has not been part of fixed capital formation.

Construction work also includes the value of equipment built in the buildings. The value of *equipment* includes costs of assembly, transport and insurance.

Sources of financing capital formation

These are all sources or expenditure necessary for financing fixed capital formation for new and existing fixed assets. They are divided into own financial assets, joint assets, financial credits, assets of funds from Slovenia and the European Union and acquisition without compensation.

Gross investment in new capacities is investment in creating new enterprises, organisations and units; construction of roads, etc., which previously did not exist or their purpose has been changed.

Gross investment for enlargement, reconstruction and renovation is investment in existing capacities because of increased volume of production or services, or because of the change of technology. It also covers reorganisation of existing buildings and equipment, and construction or purchase of new fixed assets within the scope of an existing organisationally independent unit.

Gross investment for maintenance of existing capacities at the same level is investment due to replacement, intensification and rationalisation of production, but without expanding the existing capacities or fundamentally changing the present technology.
