Vsled depresije suspendani člani

Ker je bil vsled depresije primoran marsikateri član opustiti Jednoto, nekateri pa so bili vsled finančnih težav prisiljeni znižati zavarovalnino, zato bodi sklenjeno.

Da vsi oni člani in članice, ki so bili vsled depresije primorani prenehati biti člani Jednote, lahko zopet pristopijo v Jednoto neoziraje se na njih starost pod pogojem, da se podvržejo zdravniški preiskavi in da plačajo vse assement od dne črtanja do dne zopetnega sprejema. Če bi ne mogli vsega dolga na enkrat plačati, lahko na račun dolga v mesečnih obrokih odplačajo. Zopetni sprejem se ima izvršiti najkasneje do 31. dec. 1937.

Člani, ki so bili vsled depresije prisiljeni znižati zavarovalnino jim je dovoljeno zavarovalnino zopet zvišati in sicer pod enakimi pogoji kakor v zgorajšnjem odstavku določeno. Zvišanje zavarovalnine se mora izvršiti najkasneje do 31. dec. 1937.

Ako bi tak član, ki bi na račun dolga odplačeval v mesečnih obrokih prej umrl, kot bi ves dolg Jednoti plačal, se ima preostanek neplačanega dolga odračunati od njegove (njene) posmrtnine.

70 let stari člani in članice

Pri XVII. konvenciji vršči se leta 1930 v Waukegan, Ill., je bilo sklenjeno, da od 1. jan. 1931 naprej so vsi člani in članice, ki dovršijo starost 70 let prosti assementa.

Določeno je bilo, da se assement takih članov in članic krije iz sklada izrednih podpor.

Zadnje čase se je večkrat pripetilo, da ko je član postal 70 let star, se je izkazalo, da je ob času pristopa v Jednoto navedel nepravilno starost.

V takih slučajih se je moralo člana obdavčiti kar je vsled navedbe nepravilne starosti premalo plačal, a na drugi strani pa se je dalo članu zo-

pet kredit, kar bi se imelo za takega člana iz sklada izrednih podpor za kritje njegovih assementov plačati, če bi ob pristopu v Jednoto navedel resnično in pravilno starost.

FOR GOD, HOME AND COUNTRY

About ten years ago, a young Catholic lawyer surprised the readers of the Jesuit weekly, America, with an article whose proposition was: The Catholic laity ought to know more about Canon Law.

It wouldn't enlighten many to say that Canon Law means the law of the Roman Catholic Church.

We learned six precepts of the Church from our catechisms and we have the forlorn notion that in her almost 2,000 years of existence the Church has made regulations concerning only days of obligation, fast and abstinence, Easter duty, forbidden societies, church support, and marriage.

Christ told the Church to teach, rule, and sanctify the people.

To rule means not only to judge and enforce laws but also to make laws.

It would be pitiful ruling had the Church made only six laws in her 1900 years on earth.

She has defined the rights and powers of Pope, bishops, pastors, curates, religious, not to mention their duties. She has made laws regulating sacraments, sacramentals, pious associations. Her laws cover churches, cemeteries, schools, seminaries, ecclesiastical courts, beatifications, relics. And finally she legislates concerning the punishments due to violation of her laws.

In all, her Code of Laws contains 2,414 canons or laws.

Besides these laws, she makes other regulations in the supplementary acts of the Holy See contained in the special "Acta Apostolicae Sedis," and in the various enactments of Councils and Synods. Every time the Holy Father issues an encyclical letter, he thereby adds to the laws of the Church which bind us in conscience.

Now, Father Kapistran, why

Because Father Kapistran wants to impress us with the full force of the Church seriousness when he says: Canon No. 1262 of the Church's Canon Law reads as follows: "It is desirable, in keeping with ancient discipline, that women be separated in church from the men. Men, within and without the church, while assisting at sacred services, should be without head-covering, unless approved customs of the people or peculiar circumstances of the locality govern otherwise; WOMEN, HOWEVER, MUST BE WITH COVERED HEADS AND MODESTLY ATTIRED, ESPECIALLY WHEN THEY APPROACH THE LORD'S TABLE."

And just to forestall a difficulty which Father Kapistran entertained a few days ago but entertains no longer, the good bishop who shepherds the pious ladies of Louisville, Ky., has made it known that the new "halo" hats, which are the (and I think very sensible) headgear—outside of church) for women, do not constitute "adequate" covering for women in holy places.

Of course, this legislation holds only for Louisville. But for other dioceses, it will be looked upon as a sober interpretation of what is and what is not sufficient head-dress for the daughters of Mary, in her Son's presence.

TOTAL BENEFITS PAID BY UNION OVER 6 MILLION

Secretary's Report Re-
ceives Applause From
Supreme Board

Digressing from the usual procedure of formal meetings, the Supreme Board of the KSKJ, in session July 30 for the semi-annual meeting in Joliet, Ill., interrupted the report of Supreme Secretary Zalar with spirited applause.

The manifestation followed Mr. Zalar's announcement that the KSKJ had passed the FOUR MILLION DOLLAR mark in assets held by the Union.

In announcing the Union's attainment, Mr. Zalar reported the assets of the KSKJ totaled \$4,098,933.85, as of June 30, 1937. The amount is apportioned: \$3,921,709.07 in the Adult Department, \$177,224.78 in the Juvenile Department.

The report, which comprised a general survey, disclosed that the KSKJ had paid benefits amounting to \$6,312,918, from the day of its organization to June 30, 1937. It was pointed out that the treasury of the Union in 1894, year of the organization, was depleted, and the following year consisted of only \$797.98. From that time on, the Union progressed in

finances, but it was in 1917 that the assets passed the half-million dollar mark. In the following five years the assets doubled. In 1928 the assets totaled \$2,168,812.19, while in 1932 the amount was \$3,127,114.05, and the present total \$4,098,933.85.

OUR PAGE COOKING SCHOOL

Enclosed you will find a 3-cent stamp which you may use to send us your recipe for "Potica." This recipe appeared some years ago on the Our Page in the KSKJ paper. We have lost ours and would appreciate your sending us a copy.

If you have it, please hurry it to us, for we will need it for a special occasion. Thanks a lot.

We will be looking forward to your cooking school. We surely are glad that you have started it again.

Mrs. Frank Cimermancic. Because of the above request, with which I gladly comply, I am herewith publishing the self-same recipe, because there may be others who may find use for it.

Orehova potica

Two cakes compressed yeast, 1 cup of lukewarm water, 1 cup of flour.

Dissolve the yeast in lukewarm water. When yeast begins to float on water mix in 1 cup of flour. Mix well and allow to rise for 1 hour.

Three eggs well beaten, 2 cups of milk, 2 cups of sugar, ½ pound butter, 1 tablespoon salt and 2 teaspoons lemon extract.

Beat the eggs well and add the milk, sugar, butter, salt and lemon extract. Mix this entire mixture into the yeast sponge. Mix into a soft dough, and cover with a warm cloth and set aside to raise for another hour.

One pound shelled English walnuts, 1 cup honey, 2 eggs

whites, 2 teaspoons vanilla extract, 1 cup cream, 2 teaspoon cinnamon, ¼ teaspoon cloves, and two egg yolks.

Mix the egg yolks which have been beaten with the cinnamon and cloves.

Heat the honey and add to the walnuts, also add the cream, vanilla and egg whites. Mix well, but do not add the egg yolks and spices to this mixture. Keep separate.

Then take your dough and roll out on floured cloth to about a fourth of an inch thick. Spread entire surface first with the egg yolk mixture, then with the nut mixture. Take ends of dough and roll as for jelly roll, when rolled twist toward center. Place in well greased pans in which it is to be baked, and set in a warm place, covering with cloth and allow to raise until the dough reaches the top of the pan. Then place in a hot oven and bake for about 1 hour or more if necessary.

Angel Food Cookies

One and one-quarter cups granulated sugar, 1 tablespoon cornstarch, 2 heaping teaspoons baking powder, beaten whites of 2 eggs, ¼ cup shortening, 1 cup milk, 3 cups flour, vanilla.

Beat sugar and butter together with a little milk. Add all the other ingredients except the eggs. Fold these in last, mixing thoroughly. Make dough just stiff enough to roll. Cut in any shapes desired, and bake in hot oven. Almond or lemon extract may be used instead of the vanilla.
